Pursuant to the order dated 06.03.2024 passed by this Court in W.P.(C) No. 15824 of 2018 the General Manager, Ordnance Factory, Badmal, District-Bolangir is personally present in Court today. The Collector, Bolangir is also present in Court today through Virtual Mode.3. Having heard learned counsel for the Parties, this Court directs the Collector, Bolangir to file a detailed affidavit stating the following issues:-

i) What was the instruction received from the Government of India regarding the employment of the local people in the Ordnance Factory, Badmal, District-Bolangir especially in the Group C and Group D posts;

ii) Details of the documents which the Collector, Bolangir has relied on while conducting the enquiry of the candidates and prepared the enquiry report; and
